EU DG CONNECT Blueprint – Digital Transformation of health and Care for an Ageing Society

In December 2015 at the 4th Conference of Partners of the European Innovation Partnership on Active and Healthy Ageing (EIP on AHA), European Commissioner Günther Oettinger (Digital Economy and Society) outlined how digital innovation, enabled by a functioning Digital Single Market, can transform demographic change into an opportunity for Europe's economy and society.

Commissioner Oettinger invited all stakeholders to work together with the European Commission in the development of a blueprint, a "shared vision" on how innovation enabled by a Digital Single Market can transform Europe's ageing society in the 21st century and contribute to the European Silver Economy.

EKTG submitted a response to the resultant Blueprint, including commenting on the questions raised. Maggie Ellis was able to have a meeting with Gail Kent, Acting Deputy Directorate General, DG CONNECT, and Peter Wintlev-Jensen, to discuss this, prior to the Summit. Independent review of the State Pension age: interim report PDF, 2.81MB, 100 pages

This consultation closes at 31 December 2016 5:00pm

The Pensions Act 2014 requires the government to review the State Pension age during each Parliament. The State Pension age independent review is gathering evidence and will consider a broad range of factors before making recommendations to the government in 2017.

The independent review will note existing arrangements already in law. However, it is forward looking and keen to consider the changing demographic, economic and behavioural landscape of the future. These changes, rather than the present context, will be at the heart of its recommendations on setting the right State Pension age. It is hoped, that this interim report and the questions it asks, will stimulate wider discussion. The independent review welcomes any research, insights or supporting evidence.

We have mentioned the need for people to press for use of the GP Records. In the UK there is now a raft of information about doing this. <u>Click here to download the document It's</u> <u>Your Record: A Guide to Accessing Health Records Online</u> from the NHS website.

There is now an increasing push for this and you should be encouraging your family and friends to do this for themselves. Such services include making a GP appointment, getting repeat prescriptions, reading hospital reports, latest test reports. This can also be enhanced in some places where patients can use technology to test their own blood pressure, sugar levels, etc. The results can be seen by the patient and the GP, thereby saving wasted effort where results are satisfactory, but alerting both sides where results are dodgy. There are now quite a few documents about doing this. People should apply to their own GP Surgery.
